Key Facts

Objective

Aims to provide an enhanced level of return compared with a pure cash investment, with a higher degree of capital security and stability than a fixed income bond portfolio.

The managers invest a percentage of the portfolio in a sterling-denominated money market fund with an 'AAA' rating from Standard & Poor's. However, to achieve a return above that of cash, government and corporate bonds are also included, as well as equities, alternative assets and alternative investment strategies. All of these are subject to shorter-term fluctuations in value.

The managers will adjust the asset allocation from time to time depending upon market circumstances, but not to an extent that would significantly alter the long-term risk-return profile of the investment strategy. The portfolio combines active fund managers, who aim to outperform their benchmarks (after costs), and passive investments, which offer cost-effective market exposure. The aim is to achieve better returns than the underlying markets while controlling the overall cost of the investment.

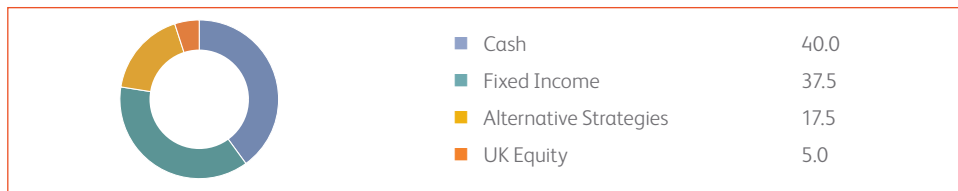

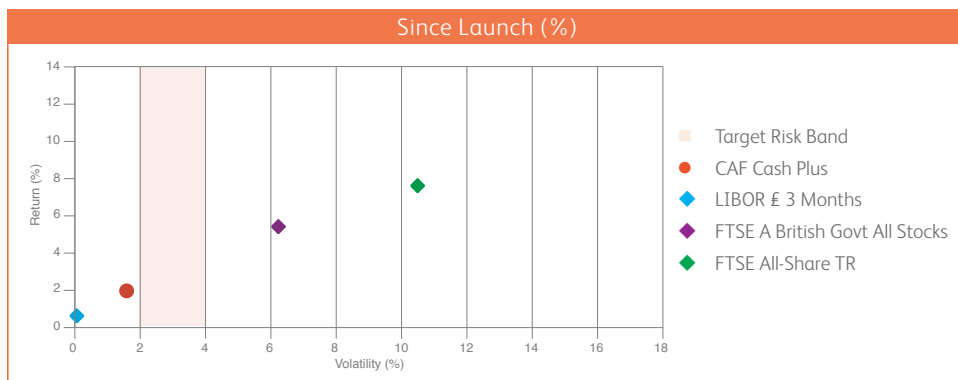
