Key Facts

Objective

Aims to generate sustained capital growth over the medium to long term by investing in global equity markets, while using other asset classes and strategies to reduce the volatility associated with equity investing.

The managers invest in equity funds, alternative investment strategies and bonds. The managers will adjust the asset allocation from time to time depending upon market circumstances, but not to an extent that would significantly alter the long-term risk-return profile of the investment strategy. The portfolio combines active fund managers, who aim to outperform their benchmarks (after costs), and passive investments, which offer cost effective market exposure. The aim is to achieve better returns than the underlying markets while controlling the overall cost of the investment.

This portfolio may be suitable for investors with a time horizon of six years or more who wish to grow their investment beyond the impact of inflation. As the Fund is a long-term investment there may be years when the capital value of the portfolio is reduced until market valuations recover again.

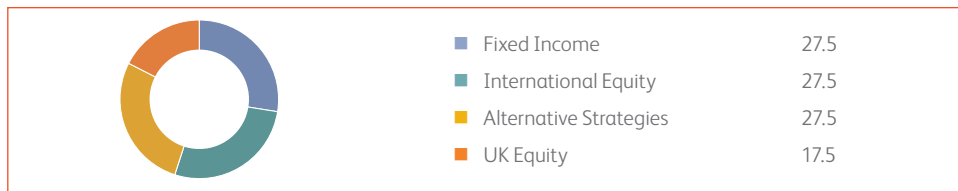
Risk Scale



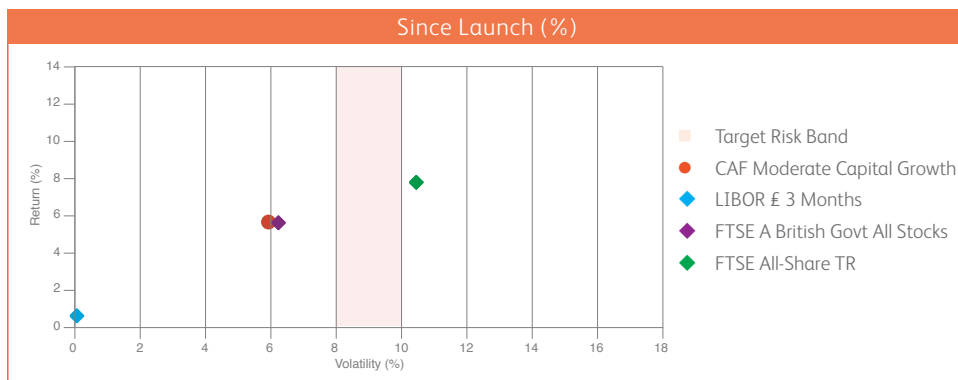
